## ASX ANNOUNCEMENT

### Afterpay / Touchcorp Merger: First Court Hearings

Afterpay Holdings Limited (ASX:**AFY**) ("**Afterpay**") is pleased to advise that the Federal Court of Australia has approved orders to convene a meeting of Afterpay's shareholders to consider and vote on the Scheme of Arrangement ("**Afterpay Scheme**") in connection with Afterpay's merger with Touchcorp Limited ("**Touchcorp**"). Under the Afterpay Scheme, all Afterpay shares (other than those held by Touchcorp and its subsidiaries) will be exchanged for new shares in Afterpay Touch Group Limited ("**ATG**") on a 1-for-1 basis.

Touchcorp (ASX:**TCH**) is also pleased to advise that the Supreme Court of Bermuda has approved orders to convene a meeting of Touchcorp's shareholders to consider and vote on the Scheme of Arrangement ("**Touchcorp Scheme**") in connection with the merger. Under the Touchcorp Scheme, all Touchcorp shares will be exchanged for new shares in ATG on the basis of 0.64 ATG shares for each Touchcorp share.

A full copy of the Scheme Booklets for each of Afterpay and Touchcorp, as approved by the respective Courts, are being separately released to ASX. The Afterpay Scheme Booklet includes an Independent Expert Report prepared by Lonergan Edwards & Associates Limited, which concludes that the Afterpay Scheme is fair and reasonable and in the best interests of Afterpay shareholders, in the absence of a superior proposal. The Touchcorp Scheme Booklet includes an Independent Expert Report prepared by RSM Corporate Australia Pty Ltd, which concludes that the Touchcorp Scheme is fair and reasonable and in the best interests of Touchcorp shareholders.
